Contract 2018-1 includes the furnishing of all labor, materials, equipment, services and incidentals for the construction of approximately 181,106 feet (34 miles) of 8-inch through 1 ½-inch ASTM 2241 PVC Gasketed Joint Pipe; road crossings; installation of (1) below grade control vault/meter vault, SCADA, connection to existing pipeline; with all appurtenant work, complete, tested and ready for operation, including temporary facilities as required, all in conformance with the Contract Documents. Approximately 47,000 feet of the pipeline route will be located within the road right-of-way. Contract 2018-1 also includes installation of one 200,000 (min) gallon welded steel or glass coated bolted steel water storage reservoir, complete with inlet/outlet piping, underdrain system, drain and overflow discharge piping, foundation, site work and site access road upgrade, outlet structure and other appurtenant items. The reservoir sizing is 30' diameter x 42' to overflow.
