Dear Land owner:

The La Plata West Water Authority (LPWWA) is working hard to bring domestic water to southwestern La Plata County. At this time, preparations are being made to construct a new water system. Phase 1 of this project will provide service to at least 200 customers and requires the construction of the main water pipelines and a water storage tank that will serve as a basis for all phases of the overall project. We are asking for your help in making this possible.

You are receiving this letter because LPWWA would like to install a domestic water pipeline across your property. The easement form is enclosed and provides for a permanent 30 foot domestic water pipeline easement. In most cases, the easement will be located within the first 50 feet of your property adjacent to the road right-of-way. This easement is non-exclusive and allows the landowner full use of the property, as long as the use does not interfere with the purpose of the easement. We ask that you not plant trees or construct permanent improvements or facilities within the easement.

When feasible, the pipeline will be installed approximately 15 feet from the road right-of-way. It may be necessary to deviate from this in cases where the pipeline is installed on the back side of a row of trees, through yards, around existing improvements, or across a drainage. We will make every effort to minimize damages and trees will be spared unless it is absolutely necessary to remove them. When going through a yard, we will take care to coordinate the pipeline location with you. Flags will be provided prior to any construction and you will be asked to advise LPWWA if there is an objection to any proposed routing.

Due to inherent increase in your property value by having a central domestic water system, LPWWA is asking all land owners to accept \$1 (ONE DOLLAR) and donate the value of easements for the benefit of the project. A certificate documenting the easement area will be provided after the easement is finalized to allow you the option of assigning a value to the donated easement for tax purposes. With the length of the water pipeline and the number of properties that are included in a project of this size and complexity, fair market compensation for easements greatly increases the cost and reduces the feasibility of the project. LPWWA representatives will be happy to respond to questions regarding easements or other aspects of the project.

We hope that the easement acquisition process moves along briskly. If you are willing to grant this easement, please sign the enclosed easement form, have it notarized, and return it to the engineer in the enclosed envelope or to one of the Board members listed below by April 1st, 2015. The LPWWA has board members that are notary publics and can witness your signature, if needed. See included information for planned meeting times and dates to ask questions or get information about the project and the easement acquisition process. Please feel free to contact a Board member with any questions you may have or if you want schedule a property visit. Our contact information is at the end of this letter and other project information is available at our website at www.lpwwa.org.

We and your neighbors thank you for your consideration in helping make this project possible.
